## **Columbus Day Trading Schedule**

Monday, October 11, 2021, is Columbus Day and is a non-settlement day. The Stock Market is open, but banks and the Fed are closed.

Due to the bank holiday, we will not be processing any distribution checks, ACHs or wires until the next business day, Tuesday, October 12, 2021.

In addition, certain aspects of our trading schedule will be impacted.

- Trade activity for the following sweep Schwab money markets will be held and processed Monday, October 11, settling Tuesday, October 12.
  - Sweep Money Markets: SWGXX
- Trade activity for the following non-sweep Schwab money markets will be executed business as usual, but will settle Tuesday, October 12.
  - Non-Sweep Money Markets: GSP2
- Exchange<sup>1</sup> trades that contain non-sweep Schwab money markets on either the buy or sell side will be executed business as usual, but settle Tuesday, October 12.
- Execution of Sell/Buy exchange trades will depend on the asset type holiday validation rules provided throughout this notification.
- Mutual Funds:
  - o Mutual Funds traded today will be executed business as usual, but will settle Tuesday, October 12.
- Equities:
  - Equities will operate business as usual. Equity trades executed today will settle Wednesday, October 13.

## Monday, October 11, 2021 - Columbus Day Holiday

- Money Markets:
  - $\circ$  The following sweep and non-sweep Schwab money markets will be processed business as usual.
    - Sweep Money Markets: SWGXX
    - Non-Sweep Money Markets: GSP2
- Mutual Funds:
  - Most funds will operate business as usual; however, certain fund companies will not accept buys and/or sells due to the non-settlement holiday which can also affect exchange<sup>1</sup> trades. Exchange<sup>1</sup> trades that contain closed funds on either the buy or sell side will be held and processed Tuesday, October 12, settling Wednesday, October 13.
  - Mutual funds that would settle today will now settle Tuesday, October 12.
- Equities:
  - Equities that would settle today will now settle Tuesday, October 12.

1. Exchange trades are single trades submitted to Schwab with a transaction type of "Exchange." **Exchange trades submitted as two** separate trades (sell and buy) will not be subject to this rule.
